RE: REQUEST FOR "NO OBJECTION" TO ADOPT SELECTIVE TENDERING FOR THE CONSTRUCTION AND EQUIPPING OF THE EXTENSION OF CERHI PROJECT BUILDING FOR THE UNIVERSITY'S WORLD BANK SPONSORED AFRICA CENTRE OF EXCELLENCE PROJECT.

This is to refer to the University of Benin's letter Ref. No. VC.68 dated December 29, 2021, which requested for issuance of Due Process "No Objection" to the University to adopt Restricted/Selective Tendering Method of procurement to invite contractors to tender for the construction and equipping of the extension of CERHI Project Building for the University's World Bank Sponsored Africa Centre for Excellence Project.

In the letter under reference, the University of Benin stated as follows: A. Background

The Africa Center of Excellence (ACE) Project was instituted in 2013 by the Governments of Nigeria, Ghana, Benin Republic, Togo, Burkina Faso, Cameroun and Senegal with support from the World Bank, to promote regional specialization amongst participating universities in the West and Central Africa sub-region within disciplines that address particular common regional challenges. It also aims at strengthening the capacities of these universities to enable them deliver high quality training and applied

To this end, the Africa Centre of Excellence in Reproductive Health and Innovation, domiciled at the University of Benin is responsible to build capacity within West Africa's tertiary educational system for implementing high quality training and applied research for reproductive

B. World Bank Funded Project:

The World Bank had approved the sum of \$300,000.00 (\$120,000,000.00) for the construction of the extension of the CERHI project building. The completion of the phase 1 CERHI project building funded by the World Bank is presently not adequate to house the growing activities of the project and thus, need to be expanded to accommodate the increasing number of students' intake and research work. The extension of the project building which forms part of the entire CERHI building project would alleviate the shortages currently affecting the growth and objectives of the establishment of the Centre and would boost excellence in

C. Justification for Selective Tendering/Contracting:

Considering the essence of time in these procurements in which if advertised could cause delay and the fund could be taken back by the sponsor (World Bank) due to lack of performance by the Centre, the university wishes to adopt the selective tendering method to engaging

competent vendors to execute these project.

Given the fact that the project is result based, the World Bank may decline further funding of the project if the Centres are not meeting the Disbursement Linked Indicators (DLI) for which the project was conceived. Therefore, it has become imperative to adopt the Selective Tendering procedure for the University to meet the DLI and in line with the provision of Section 40 (b & C) of the Public Procurement Act 2007. The Bureau is also invited to note that the Centre is adopting this method as an exception rather than the norm.

The Project will be funded from World Bank Support Fund. (Attached is the evidence of funding)

Knowledge and Cognate Experience: It is imperative that a competent firm with cognate experience in the construction of academic research building is engaged to deliver in terms of quality and timing while also offering competitive price so as to obtain value for money. The University has identified some companies that have previous business with Federal Government of Nigeria, which provides the advantage of having adequate knowledge of the assignment and has proven speedy completion of the projects while ensuring quality. The companies that meet up with the requirement of the provisions of section 16(6)(c) of the PPA, 2007 that can do business with Federal Government of Nigeria to effectively carry out the implementation of this project as detailed below.

## D. Proposal and Profile:

Please find attached profiles of the companies upon which Certificate of 'No Objection' for Selective tendering are sought is attached for ease of reference.

- 3. The Bureau has carefully reviewed the request of the University and observed as follows:
  - (a) The University of Benin in a bid to expand the phase 1 of the CERHI project building funded by the World Bank to accommodate the increasing number

of students' intake and research work is desirous to adopt Selective Tendering Method to ensure quick actualisation of the project. In order to achieve that the University vide letter Ref. No. VC.68 dated December 29, 2021, requested for issuance of Due Process "No Objection" to the University to adopt Selective Tendering Method of procurement to invite contractors to tender for the Construction and Equipping of the Extension of CERHI Project Building for the University's World Bank sponsored Africa Centre of Excellence Project.

(b) The University cited the essence of time in this procurement, which if subjected to open competitive bidding, could cause delay and the fund could be taken back by the sponsor (World Bank) due to lack of performance by the Centre as grounds for the request to adopt

Restricted/Selective Tendering Method of procurement.

(c) Accordingly, the University identified and short listed six (6) companies listed in paragraph 2(C) above, considered to be technically competent to execute the project, for consideration for Selective/Restricted Tendering Procurement Method.

(d)In line with the provisions of Section 16(1)(b) of the PPA, 2007, University indicated that the sum of \$300,000.00 (\\120,000,000.00) has been approved by the World Bank for the construction of the extension of the CERHI project building.

The attention of the University is drawn to note some of the basic principles, which govern Special and Restricted Methods of Procurement as stipulated under Section 40 of the Public Procurement Act (PPA), 2007 due to urgency which is not the result of dilatory conduct on the part of the procuring entity. The applicable relevant Clauses of Section 40 of the PPA, 2007 are as follows:-

(a)clause 40(1)a: "the goods, works or services are available only from a

limited number of suppliers or contractors";

(b)clause 40(1)b: "the time and cost required to examine and evaluate a large number of tenders is disproportionate to the value of the good, works or services to be procured"; or

(c)clause 40(1)c: "the procedure is used as an exception rather than norm".

The essence of time being cited by the University as the reason to adopt 5. Selective Tendering is not supported by any of the provisions of Section 40 of the PPA, 2007. However, the Bureau considered the current incidence of the Covid-19 Pandemic, especially the Omicron Variant in Nigeria with its attendant restriction on gathering and noted that subjecting this procurement to open competitive bidding at this time would provide grounds for gathering of large number of potential bidders, which might result in person-to-person contact and further aggravate the spread of the virus and delay in the implementation of the project. Therefore, the request by the University to adopt Restricted/Selective

Tendering Method can be considered as an exception rather than a norm in line with Section 40(1)(c) of the PPA, 2007.

Consequently, the Bureau has reviewed the profiles of the companies forwarded by the University to ensure they fulfil the requirements of Section 16(6) of the PPA, 2007 and comply with the SGF's Circular Ref. No. SGF/50/S.52/II dated December 11, 2014 on the registration on the National Database of Federal Contractors, Consultants and Service Providers. The summary of the outcome of the Bureau's review is shown in Table 6.1 below:

- From the review of the profiles of the companies in Table 6.1 above, the Bureau observed that four (4) out of the six (6) short-listed companies are responsive, having fulfilled all the eligibility criteria stated in Section 16(6) of the PPA, 2007 and complied with the SGF's Circular Ref. No. SGF/50/S.52/II dated December 11, 2014. However, the University should ensure that the approved short-listed companies provide evidence of OEM authorisation (to support the equipping part of the procurement) as a condition to participate in the financial
- In view of the foregoing, Due Process "No Objection" CANNOT be granted to the University of Benin to adopt Restricted/Selective Tendering Method of Procurement to invite contractors to tender for the construction and equipping of the extension of CERHI Project Building for the University's World Bank Sponsored Africa Centre for Excellence Project, in favour of the under listed companies as follows:
  - i. Ree Engineering Limited
  - ii. Pet Homes Limited
  - iii. Switch Tech Mega Solutions Limited
  - iv. Communication Effects Nigeria Limited
  - v. Muhild Nigeria Limited
  - vi. ABBZ Engineering Services Limited.
- However, Due Process "No Objection" CAN be granted to the University of 9. Benin to adopt Restricted/Selective Tendering Method of Procurement to invite contractors to tender for the construction and equipping of the extension of

CERHI Project Building for the University's World Bank Sponsored Africa Centre for Excellence Project, in favour of the under listed companies as follows:

i. Ree Engineering Limited

ii. Pet Homes Limited

iii. Switch Tech Mega Solutions Limited

iv. Muhild Nigeria Limited.

10. The University of Benin should:

(a) Ensure that the approved short-listed companies provide evidence of OEM authorisation (to support the equipping part of the procurement)

as a condition to participate in the financial tender;

(b) Proceed and issue relevant Standard Bidding Documents to the approved shortlisted Companies in line with the SGF's Circular Ref. No. SGF50/S.52/II/469 dated January 13, 2017 for the bidders to submit their financial tenders and ensure a healthy competition among them.

(c) Ensure that only financial competitiveness form the basis for the

determination of the winning bid.

(d)Conduct Due Diligence/Post Qualification in line with the resolution of the Federal Executive Council's (FEC) meeting held on May 17, 2017 and SGF's Circular Ref. No. SGF.50/5.52/III/652 dated October 11, 2017 on the recommended company before award of the contract. The Due Diligence Report should include but not limited to:

i. Names of the Directors of the Company;

ii. Professional and technical qualifications of personnel required to carry out the procurement;

iii. Financial capability;

iv. Equipment and other relevant infrastructure;

v. Verification of adequate personnel to perform the obligations of the procurement contract;

vi. Possesses the legal capacity to enter into contract with the Federal Government;

vii. Not in receivership, subject of any form of insolvency or bankruptcy proceedings or the subject of any form of winding up petition or proceedings;

viii. Have fulfilled all the obligation with regards to payments of taxes,

pensions and social security contributions;

- ix. Not have any Director who has been convicted in any Country for criminal offences relating to fraud or financial impropriety or criminal misrepresentation or falsification of facts relating to any matter.
- (e) Be guided by the approval Threshold stipulated in the SGF's Circular Ref. No: SGF/OP/I/S.3/VIII/57 dated 11th March, 2009 and the revised Circular Ref. No: SGF/OP/I/S.3/XI/849 dated 14th January, 2016 in approving the project.

(f) Ensure records of all the processes are properly kept, in line with Section 16(12) of the PPA, 2007, for future procurement audit that will be carried out by the Bureau as stipulated in Section 5(p) of the PPA, 2007.

(g)Ensure that the University's 2021 Procurement Plans and 2019/2020 Procurement Records are submitted through the Nigeria Open Contracting Portal (NOCOPO), which can be accessed on the Bureau's website (www.bpp.gov.ng) (nocopo.bpp.gov.ng), in line with SGF's Circular Ref. No. PROC/BPP/045/II dated 6th March 2020. The University should ensure that this procurement is uploaded on the NOCOPO from planning to project implementation.

(h)Ensure that any procurement that directly responds to the COVID-19 pandemic should be implemented in line with the PTF and BPP Guidelines, which are available on the BPP website (www.bpp.gov.ng). These Guidelines are to ensure transparency, accountability, probity and value for money in the conduct of COVID-19 related procurements.

(i) Aggregate and reprioritize their procurements for the Year 2021 to ensure economies of scale and reduce procurement costs.

#### 2.0 OBSERVATIONS:

MESSRS MUHLID NIGERIA LIMITED: The tender sum of ₱199,329,133.75 does not have arithmetic error but with a percentage deviation of +65.45% from the reserved price. Their stated completion period of 5 months is the same as the required completion period of the project. From the analysis in table 2, it is clear that the elemental rates are not competitive compared to the reserved rates.

MESSRS REE ENGINEERING LIMITED: The tender sum of \$137,142,791.75 had no arithmetical error but with a +13.84% deviation from the reserved price. Their stated completion period of 5 months is the same as the required completion period of the project. Their elemental rates are competitive compared to the reserved rates.

MESSRS PET HOMES LIMITED: The tender sum of ₹177,695,228.20 had an arithmetic error of minus ₹40,149,137.20, bringing their corrected sum to ₹137,546,091 with a +14.17% deviation from the reserved price. Their presented financial bid was incomplete and shows sign of incompetency hence their elements could not be properly analysed. Their stated completion period of 5 months is the same as the required completion period of the project. Their rates are not competitive compared to the reserved price.

MESSRS SWITCH TECH. MEGA SOLUTIONS LIMITED: Their tender sum of ₦118,718,703.55 had an arithmetic error of -135,928.38 and had a -1.57% deviation from the reserved price. Their stated completion period of 5 months is the same as the required completion period of the project. Their rates are competitive.

#### 3.0 SUMMARY

None of the tenders met the exact Reserved Tender Sum. They all met the required completion period.

Based on the criteria and parameters used as shown above, the following show a level of responsive and reliable evaluated tender:

MESSRS PET HOMES LIMITED: The tender sum of №177,695,228.20 had an arithmetic error of minus №40,149,137.20, bringing their corrected sum to

Name 137,546,091 with a +14.17% deviation from the reserved price. Their presented financial bid was incomplete and shows sign of incompetency hence their elements could not be properly analysed. Their stated completion period of 5 months is the same as the required completion period of the project. Their rates are not competitive compared to the reserved price.

MESSRS SWITCH TECH. MEGA SOLUTIONS LIMITED: Their tender sum of №118,718,703.55 had an arithmetic error of -135,928.38 and had a -1.57% deviation from the reserved price. Their stated completion period of 5 months is the same as the required completion period of the project. Their rates are competitive.

## 3.0 SUMMARY OF ANALYSES

None of the tenders met the exact Reserved Tender Sum. They all met the required completion period.
